Annex 1:

Ms Kroes is the 100%-shareholder of a BV (a limited liability company according to Dutch law). The articles of association of this BV have been amended. The official authorities, including the Ministry of Justice, of the Netherlands approved this change. The sole purpose of Bergsche Maas BV is the passive investment of cash in order to fulfil the future pension payments to Ms Kroes.

Ms Kroes has established a so-called Foundation ('Stichting Administratiekantoor', hereinafter to be referred 'Stichting') with two independent members in the board, unknown to Ms Kroes. She transferred the legal ownership of the shares to the 'Stichting'. In exchange she received depository receipts ('certificaten van aandelen'). The voting rights (including the right to pay out a dividend) attached to the shares are in the possession of the 'Stichting'. The depository receipts reflect only the economic value of the shares. It is prohibited to convert these depository receipts into common shares during the period that she is a Commissioner in the European Commission.

This structure is commonly known under Dutch law and also used and approved by Dutch cabinet-ministers or deputy-ministers with business interests in the form of a substantial share in a BV. The structure is comparable with an irrevocable trust, governed by and independent trustee with discretionary powers under Anglo-Saxon law.

Ms Kroes resigned as a managing director of the BV. A new independent managing director of the BV has been appointed. As of September 1st, 2004, he has not received any salary from the BV.

As far as the cash of the pension-BV will be invested, the rules of the Code of Conduct will be fully respected. The BV will only invest money in certificates of investment funds (unit-trust) on basis of a discretionary mandate given to a bank.

As explained above, Ms Kroes is not entitled and will not take any decisions about the investments of the BV. The director (trustee) will passively follow the performance of the investments in unit-trusts.
